The meeting was called to order at 17:05 by Jeremy Miller. The main point on the agenda was the edited version of SEFA 11 by Josiah Wartak, a professional editor.

The document was received only two days prior to the meeting so time to check was limited. After briefly reviewing the changes, the group agreed that a thorough check takes more time. Sascha and Jeremy will go through the document and meet online in the short term. After they have made their comments, the document will be circulated by Barbara to get feedback from all interested parties. On the next SEFA 11 web meeting those changes will be incorporated and further discussed.

There was some further debate about whether or not an actual 3rd party certification such as UK 1275 or FM 6050 is mandatory in North America. The consensus was that not necessarily but it depends on the AHJ. The topic of ventilation was raised again but that also depends largely on the AHJ. The meeting was adjourned at 17:35. Motion was made by Luke Savage, seconded by Todd Wilhite.
